

# **INVITATION TO BID (ITB)**

#### **Maintenance Truck with Trade-in**

Gulf Bend Center (GBC) is a community center in the State of Texas formed as the result of legislation passed in 1965. GBC is a 50l(c)(3) non-profit agency governed by a nine-member Board of Trustees. It has grown from a small organization offering limited services to a major behavioral health provider, serving over 8000 individuals annually in a comprehensive array of mental health, intellectual developmental disabilities services, and substance use services. GBC provides services in a seven-county region that includes: Victoria, Jackson, Calhoun, Refugio, Goliad, Dewitt, and Lavaca Counties.

GBC is requesting bids from qualified vendors to purchase one (1) maintenance truck with trade-in of one (1) GBC owned maintenance truck. GBC is seeking a new or used light duty truck with a minimum of a six (6) foot bed. GBC's current maintenance truck to be traded-in is a 2005 Ford F250. See page 3 for more information on specifications for both vehicles.

Sales Tax: As a 501(c)3, GBC is exempt from Federal excise tax and Texas sales and use tax and therefore sales tax should not be included in the bid.

Late Bids: Bids received after submission deadline will be rejected. GBC is not responsible for lateness or non-delivery of carrier, email, etc.

Contract: This bid, when properly accepted by GBC, shall constitute a contract equally binding between the successful bidder and GBC. No different or additional terms will become a part of the bid.

*Delivery:* Unless local, delivery of vehicle and pick up of trade in should be to 6502 Nursery Drive, Victoria Texas. All delivery and freight charges may be included in the bid price.

Exceptions or Substitutions: All bids meeting the intent of this ITB will be considered for award. Bidders taking exception to the specifications, or offering substitutions, shall clearly state this information. GBC reserves the right to accept all or none of the exceptions and/or substitutions deemed to be in the best interest of GBC.

*Vehicles* or items supplied under this contract shall be subject to GBC's approval. Vehicles found defective or not meeting specifications will be picked up and replaced by the successful bidder within reasonable time at no expense to GBC.
